Re: Request for Support for Business Accelerator Project

To support a diversified economy in Tompkins County, IAED is undertaking a project to create a new business accelerator to house a cluster of businesses sharing a designated cluster.

Such an Accelerator (meant to attract firms both within and beyond Tompkins County) can help strengthen the local economy at a time when the community is actively concerned about its future. Clustering firms from a common market segment encourages collaborative product development and marketing, with the opportunity to share resources (such as expensive equipment supplied by the Accelerator) that few or none could afford independently.

To determine if there is a viable cluster of companies that would benefit from co-location, IAED has engaged the services of Galileo Technology Group, based in Orange County, NY. Galileo has successfully implemented several accelerators in other parts of the state and, facilitated by IAED this summer, undertook a SWOT analysis to determine the potential for a similar entity in Ithaca.

A cross section of thought leaders in the community met to evaluate the potential and determined that companies developing Assistive Technologies (with an initial target of eldercare) could be a viable candidate.

IAED requests \$20,000 from the TCDC to undertake a three-month pilot project to further assess its viability. The resources will enable Galileo Technology Group and IAED to:

- Identify and contact potential participant companies;
- · Evaluate possible locations as well as funding opportunities for build-out; and
- Design a conference in the Assistive Technology field that will build momentum and spur interest from candidate companies.

Following this pilot IAED and Galileo will assess the prospects for moving forward. Additional financial support may be requested at that time, should the potential for success be demonstrated.
